### WHERE WE BEGAN AND HOW WE HAVE CHANGED - PALLIATIVE CARE HALF A CENTURY LATER

**DR. BERNARD LAPOINTE** 8:30 - 9:30 AM



Dr. Lapointe, began his career in family medicine not long after graduating from the Université de Sherbrooke medical school. He has dedicated his career to the care of the dying, at all levels and across provincial and national jurisdictions. He has provided palliative care to patients, advocated for them, and conducted research to find new analgesic solutions to address their pain. In 1991, he returned to full-time medical practice at the Royal Victoria Palliative Care Service. He was appointed Director of Palliative Care Services in the Université de Montréal Hospital Center in 1998, and in 2001 he became the Chief of the Division of Supportive Care and Palliative Care at Jewish General Hospital, a role he enjoys to this day. In addition, he is an associate professor of palliative medicine in McGill University's Departments of Family Medicine and Oncology. He has held the Eric M. Flanders Chair in Palliative Medicine at McGill University since 2009 and was past-president of the Palliative Care Association of Quebec and the Canadian Hospice Palliative Care Association. Dr. Lapointe was awarded the 2017 Lifetime Achievement Award from Canadian Society of Palliative Care Physicians.

### RESEARCH 101: POKING AND PRYING WITH A PURPOSE

**DR. SUSAN MCCLEMENT** 2:30 - 3:30 PM



Dr. Susan McClement is a Professor in the Rady Faculty of Health Sciences College of Nursing at the University of Manitoba, and holds specialty certification in Hospice Palliative Care Nursing from the Canadian Nurses Association. She has been involved in international palliative care education at the graduate and undergraduate level, teaching students in Cuba, and Sichuan University in Chengdu, China and is a past recipient of the University of Manitoba Graduate Students' Association award for excellence in graduate teaching. Dr. McClement's research interests include the psychosocial dimensions of cancer anorexia cachexia, ethical issues in palliative care; understanding compassion in end of life care, and identifying the nature of expert nursing practice in those with life-limiting illness. Her work has been funded by the Canadian Institutes of Health Research, and the Canadian Cancer Society Research Institute. She is a past member of the board of Palliative Manitoba, and currently sits as a board member for Manitoba Medical Services Foundation and Research Manitoba.

André Picard is one of Canada's top health and public policy observers and commentators. He is the health columnist at The Globe and Mail, where he has been a staff writer for more than 30 years. He is also the author of numerous books and has received much acclaim for his writing and for his dedication to improving healthcare. Including the Michener Award for Meritorious Public Service Journalism and the Centennial Prize of the Pan-American Health Association, awarded to the top health journalist in the Americas. He is also an eight-time finalist for the National Newspaper Awards – Canada's version of the Pulitzer Prize. In 2013, he was awarded the Media Award from Canadian Hospice and Palliative Care Association in recognition of the several excellent articles he wrote on hospice palliative care throughout 2012-2013.

Dr. Harlos has worked in palliative care for 27 years. He is Medical Director for Palliative Care for the Winnipeg Regional Health Authority, serving in that role since its inception 19 years ago. He developed the Pediatric Palliative Care Service in Winnipeg in 2006, after spending a year-long sabbatical in various pediatric palliative care programs in Canada and the United States. He founded the Canadian Network of Palliative Care for Children in 2003, and was a founding Co-Chair. Dr. Harlos is a Professor and the founding Section Head of Palliative Medicine in the Max Rady College of Medicine, University of Manitoba. He has been in the role of Clinical Team Leader for the Canadian Virtual Hospice since its beginning in 2003. Dr. Harlos has received the Canadian Hospice and Palliative Care Association Award of Excellence (2006) as well as its award for Pediatric Palliative Care (2017). Has also received the Canadian Society of Palliative Care Physicians Eduardo Bruera Award in Palliative Medicine (2007), and in 2004 was awarded the Companion of Hospice Award by Hospice and Palliative Care Manitoba. For his contribution to Palliative Care nationally, Dr. Harlos received the Queen Elizabeth II Diamond Jubilee Medal in 2012.
